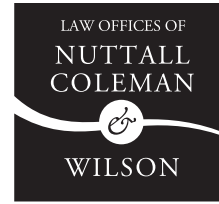

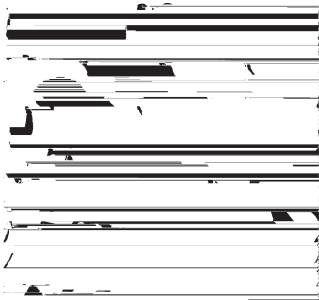

 student finisher in each race.

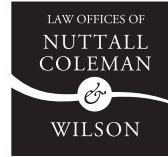
